ADJOURNMENT

Disclosure of Campaign Contributions – Government Code Section 84308 requires that campaign disclosure reports provide the public with the identity of contributors and the amounts they give, and the amount that officeholders, candidates, and committees spend. A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an “entitlement for use” (such as an annexation or sphere amendment) if, within 12 months, the Commissioner has received \$250.00 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application (such as an attorney, engineer, or planning consultant) representing the applicant or interested party. The law also requires any applicant or participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding. The law also prohibits an applicant from making a contribution of \$250.00, or more to a LAFCO Commissioner while a proceeding is pending or for 3 months afterward.

Disclosure of Expenses Supporting and Opposing Proposals - If a person or group contributes or expends \$1,000.00 or more in support of, or in opposition to, a proposal before LAFCO, those contributions and expenditures must be disclosed. Pursuant to Section 56100.1 of the Government Code, disclosure shall be made to the Commission's executive officer.

RE: Public Hearing Procedures

In light of current COVID 19 Health Orders and the LAFCO Commission meeting being held via the Zoom Platform, County Counsel has advised that the LAFCO Commission may modify the public comment procedures for public hearings at the May 26, 2020 meeting.

Due to the modified meeting format and tele-conferencing meeting procedures, the Chair may choose to allow public comment on the project in an alternative fashion, rather than calling for those in favor, those in opposition, those neutral, and then any rebuttals or surrebuttals. The Chair may take public comment on the project in any order in lieu of the calling for those in favor, opposition, neutral, rebuttals, and then surrebuttals.

The Commission may elect to allow the applicant or applicant representative a specific time to speak on the project prior to taking public comments on the item. This opportunity could have a specific time length allotted, such as five or ten minutes.

As a reminder, those who wish to provide information during the public comment are not required to provide their name. County staff will notify the Chair of any individuals who wish to provide testimony and will limit the testimony to the time limit identified by the Chair.

If an item on the agenda is not identified as a “public hearing”, public comment is still required and can be conducted in a similar format to the modified procedures above.

All votes require a roll call with each commissioner to be named by County Staff prior to stating their vote. The Chair shall also identify by name the commissioner who initiated the motion and the name of the commissioner who seconds the motion. After a second is named, the Chair must allow County staff to complete a roll call vote.

It is possible that a delay may occur from the time the Chair calls for public comment on a project and when County staff can connect them into the zoom meeting. It is recommended that the Chair pause for 60-90 seconds after calling for public comment to allow for any connections to occur. If there are no individuals in the queue for commenting on a specific item, after 90 seconds has elapsed County staff will notify the Chair that there is no further public comment.

Staff may need to respond to emails or phone calls from members of the public during the meeting to provide assistance to the public if they encounter problems using the Zoom platform. Staff requests that the Chair allow additional time as needed to ensure that members of the public can engage in the meeting.

EXECUTIVE OFFICER'S REPORT

PROPOSED ACTION

Consideration of adopting a Resolution which determines terms and procedures for special district members on the LAFCO Commission, requires special districts pay one third of the annual LAFCO budget beginning in FY 20-21, sets forth the apportionment of annual LAFCO fees between special districts, directs LAFCO staff to bill special districts for one third of LAFCO annual operating costs, accepts special district election results, and appoints two special district members and one special district alternate to the LAFCO Commission.

BACKGROUND

1. LAFCO is currently comprised of two County Supervisors, two City Council Members, one Public Member and one Public Member Alternate.
2. State law allows LAFCO's to expand their membership by adding two independent special district representatives as per California Government Code Section 56332.
3. Many of the special districts in Tuolumne County began meeting on May 3, 2018 to discuss special district membership on Tuolumne County LAFCO. On October 23, 2018 nine special districts submitted resolutions asking the LAFCO Commission to begin the process of expanding the LAFCO Commission to include special district representation and proposed that special districts together pay 8% of the LAFCO budget.
4. After a series of discussion among the districts and with LAFCO staff, the proposal came before Tuolumne County LAFCO on April 8, 2019. The Commission adopted Resolution 296 which outlined procedures for adding special district members and holding elections. A copy of the staff report, Resolution 296 and minutes of the April 8, 2019 meeting are attached.
5. The default LAFCO budget apportionment for LAFCO Commissions with city, county and special district representation is for each of these to pay one third of the LAFCO annual budget. Any alternative method of apportionment must be approved by a majority vote of each group. The proposal from the special districts to pay 8% of the LAFCO budget would require approval from the City of Sonora, County Board of Supervisors and a majority of the independent special districts in the County.
6. On May 29, 2019 special districts met with LAFCO staff to discuss the balloting process and share of cost. There was consensus to move forward with the election of two special district members and one alternate and to have special districts pay the default budget apportionment of one third of the LAFCO annual budget. The City of Sonora would continue to contribute to the LAFCO budget pursuant to a Memorandum of Understanding (MOU) between the City and the County. The City's share is based on the Local Transportation Fund (LTF) per capita percentage. Under this formula, the City is responsible for 8.1 percent of the LAFCO Budget. In the past, the County was responsible for the remaining balance not covered by application fees. With the addition of Special District representatives on the LAFCO Commission, the County's portion will be approximately 48%. Approximately 11% of the budget is anticipated to

come from application fees.

7. Special districts were asked to submit resolutions in which they indicate whether they support the election, nominate a candidate if so desired, and specify the special district share of cost.
8. Ten resolutions were received on November 1, 2019 from the following special districts:
 - Tuolumne Utilities District,
 - Jamestown Sanitary District,
 - Tuolumne Fire District,
 - Tuolumne Park and Recreation District,
 - Tuolumne City Sanitary District,
 - Groveland Community Services District,
 - Twain Harte Community Services District,
 - Columbia Fire Protection District,
 - Strawberry Fire Protection District, and
 - Mi-Wuk Sugar Pine Fire Protection District.
9. All district resolutions specified that special districts together pay one third of the LAFCO annual budget. The resolutions outlined the division of cost between districts. The resolutions left out Tuolumne Park and Recreation District and included the Tuolumne County Resource Conservation District (TCRCD), which was an apparent clerical error. Tuolumne Park and Recreation District submitted a resolution to participate as a Special District and has participated fully in the process. Staff has updated the table below, originally received from the Independent Special District Selection Committee and the Special Districts, to include the Tuolumne Park and Recreation District and have them pay the same amount as the cemetery districts, which corrects the clerical error.

Further, historically LAFCO has not reviewed TCRCD, because their sphere of influence includes the entire County. Thus, LAFCO does not review this district as part of the Municipal Service Review process which evaluates whether a special district's service area and sphere of influence continue to be appropriate. Because TCRCD has not been involved in LAFCO and has not historically been reviewed by LAFCO, they were not included in the special district

voting process. Therefore, the Independent Special District Selection Committee did not propose them as a paying member of LAFCO. Due to these special circumstances, the TCRCO has been removed from the table above as a paying member of LAFCO, although they will continue to receive agenda packets and be welcome to attend LAFCO meetings as are all special districts

10. The resolutions stated that initial allocations listed above shall be adjusted proportionally based on changes to the Tuolumne LAFCO budget annually or as otherwise agreed by a majority vote of the special district selection committee. The LAFCO Commission acted as the special district selection committee for purposes of this election.
11. The resolutions also addressed the terms and procedures for special district representation. During meetings between LAFCO staff and special districts, LAFCO staff raised questions concerning voting procedures, term limits and other administrative issues and requested that special districts work together to consider these issues and address them in their resolution.
12. All resolutions indicated that special district members serving on the Tuolumne County LAFCO shall not be disqualified from voting on proposals affecting their own special district. This is in line with similar policies in the current Tuolumne County LAFCO Policy and Procedure Manual (last amended 3/14/11). Rule 15 – Disqualification of Members on Voting states, *The representation by a member or alternate of the City of Sonora shall not disqualify, or be cause for disqualification of, the member or alternate from acting on a proposal affecting the City, as provided in Government Code Section 56336.* Rule 19 – Disqualification of Members from Voting states, *No member of the Commission is disqualified from voting on any item being considered by the Commission, except in those instances in which the member has a financial conflict of interest. In any situation in which the member disqualifies himself or herself for whatever reason or is absent, the Alternate member will note.*
13. The resolutions set terms as follows:

Upon enlargement of the commission to include independent special districts, the term for one new special district member, selected from any independent special district in Tuolumne County, shall coincide with the term of the existing commission member who holds the office represented by the original two-year term on the commission. The term of the second special district member coincides with the term of the existing commission member who holds the office represented by the original four-year term of the commission. This second special district member shall be from the Tuolumne Utilities District, Groveland Community Services District, or Twain Harte Community Services District, and this commission position shall then rotate consecutively to the next agency in the above listed order following each term.
14. The resolutions nominated candidates for each of the special district member seats and a special district alternate member, thus signaling their desire to add two special district members and one special district alternate to the LAFCO Commission.

SPECIAL DISTRICT REPRESENTATIVE BALLOT PROCESS

15. LAFCO staff sent out special district member ballots to all 18 eligible voting districts on December 23, 2019. A copy of the ballot is attached. Voting was extended to March 2, 2020 based on requests from special districts for more time to take the item to their boards.
16. Each district was entitled to one vote cast by the special district presiding officer designated as the voting member by the special district. Ballots from at least a quorum of special district voting members were required. Eleven districts returned ballots which is more than the required quorum of votes.

17. Elected special district representatives are as follows:

Seat 1 - Rotating Between TUD, Groveland CSD and Twain Harte CSD:
Ron Kopf, TUD, 8 votes

Seat 2 - Special District General Member:
John Feriani, Tuolumne City Sanitary District, 5 votes

Alternate - Special District Member:
Adam Artzer, Tuolumne Fire District, 4 votes

ENVIRONMENTAL ANALYSIS

18. The action to seat independent special district representatives on LAFCO is categorically exempt from environmental review pursuant to Section 15320 of the State CEQA Guidelines because the action is limited to changes to the organizational structure of a local governmental agency and does not change the geographical area in which previously existing powers are exercised.

RECOMMENDATION

The Executive Officer recommends that your Commission adopt a Resolution which determines terms and procedures for special district members on the LAFCO Commission, requires special districts pay one third of the annual LAFCO budget beginning in FY 20-21, sets forth the apportionment of annual LAFCO fees between special districts, directs LAFCO staff to bill special districts for one third of LAFCO annual operating costs, accepts special district election results, and appoints two special district members and one special district alternate to the LAFCO Commission.

The resolution sets forth the following:

- The LAFCO Commission shall be expanded to include two special district members and one special district alternate. Upon enlargement of the commission to include independent special districts, the term for one new special district member, selected from any independent special district in Tuolumne County, shall coincide with the term of the existing commission member who holds the office represented by the original two-year term on the commission. The term of the second special district member coincides with the term of the existing commission member who holds the office represented by the original four-year term of the commission. This second special district member shall be from the Tuolumne Utilities District, Groveland Community Services District, or Twain Harte Community Services District, and this commission position shall then rotate consecutively to the next agency in the above listed order following each term.
- Special district members serving on the Tuolumne County LAFCO shall not be disqualified from voting on proposals affecting their own special district.
- Special districts shall pay one third of the LAFCO annual budget.

- Initial (FY 20-21) allocations shall be adjusted proportionally based on changes to the Tuolumne LAFCO budget annually or as otherwise agreed by a majority vote of the LAFCO Commission.
- The LAFCO Commission directs LAFCO staff to bill special districts annually.
- The Commission approves the special district ballot process and accepts the election results.
- The Commission appoints two special district members and one special district alternate to the Tuolumne County LAFCO Commission. Candidates for appointment are those receiving a majority of votes cast by special districts eligible to vote. Appointed members are:

Seat 1 - Rotating Between TUD, Groveland CSD and Twain Harte CSD:
Ron Kopf, TUD

Seat 2 - Special District General Member:
John Feriani, Tuolumne City Sanitary District

Alternate - Special District Member:
Adam Artzer, Tuolumne Fire District

OF THE COUNTY OF TUOLUMNE, STATE OF CALIFORNIA

ESTABLISHING THE TERMS AND PROCEDURES FOR LAFCO COMMISSION SPECIAL DISTRICT MEMBERS, REQUIRING SPECIAL DISTRICTS TO PAY ONE THIRD OF THE ANNUAL LAFCO BUDGET BEGINNING IN FY 20-21, SETTING FORTH THE APPORTIONMENT OF ANNUAL LAFCO FEES BETWEEN SPECIAL DISTRICTS, DIRECTING LAFCO STAFF TO BILL SPECIAL DISTRICTS FOR ONE THIRD OF LAFCO ANNUAL OPERATING COSTS, ACCEPTING SPECIAL DISTRICT ELECTION RESULTS, AND APPOINTING TWO SPECIAL DISTRICT MEMBERS AND ONE SPECIAL DISTRICT ALTERNATE TO THE LAFCO COMMISSION.

WHEREAS, pursuant to Government Code Section 56332.5, when a LAFCO does not have independent special district representation, the LAFCO must initiate proceedings for such representation upon receipt of a written request by one or more independent special districts representing 10% or more of the assessed value of taxable property in the County, as shown on the last equalized County assessment roll; and

WHEREAS, the Commission adopted Resolution 296 on April 8, 2019 to initiate proceedings to add special district members to the LAFCO Commission in response to receiving resolutions from nine of the independent special districts in Tuolumne County, representing 10% or more of the assessed value of taxable property in the County, requesting special district representation on LAFCO; and

WHEREAS, on November 1, 2019 LAFCO received 10 resolutions from the following special districts in which each requested that two special district members and one special district alternate be added to the LAFCO Commission:

- Tuolumne Utilities District,
- Jamestown Sanitary District,
- Tuolumne Fire District,
- Tuolumne Park and Recreation District,
- Tuolumne City Sanitary District,
- Groveland Community Services District,
- Twain Harte Community Services District,
- Columbia Fire Protection District,
- Strawberry Fire Protection District, and
- Mi-Wuk Sugar Pine Fire Protection District; and

WHEREAS, the Tuolumne County LAFCO Commission wishes to amend the apportionment of special district payments outlined in the special district resolution to add Tuolumne Park and Recreation District as a paying member, having determined that they were inadvertently left off of the district resolutions due to a clerical error, and determine that they will pay the same amount as the cemetery districts. The Commission also wishes to amend the apportionment by removing Tuolumne County Resource Conservation District as a paying member due to their special circumstance that they are not reviewed by LAFCO; and

WHEREAS, pursuant to Government Code Section 56381(b)(1)(A), when there is county, city and special district representation, the default LAFCO budget apportionment is one-third shares for the county, the cities, and the special districts; and

WHEREAS, the special districts seeking LAFCO representation have requested to pay the default LAFCO budget allocation formula of one third to be shared among the special districts.

NOW, THEREFORE, BE IT RESOLVED that the County of Tuolumne Local Agency Formation Commission does hereby determine and order as follows:

SECTION 1: The LAFCO Commission shall be expanded to include two special district members and one special district alternate. Upon enlargement of the commission to include independent special districts, the term for one new special district member, selected from any independent special district in Tuolumne County, shall coincide with the term of the existing commission member who holds the office represented by the original two-year term on the commission. The term of the second special district member coincides with the term of the existing commission member who holds the office represented by the original four-year term of the commission. This second special district member shall be from the Tuolumne Utilities District, Groveland Community Services District, or Twain Harte Community Services District, and this commission position shall then rotate consecutively to the next agency in the above listed order following each term.

SECTION 2: Special district members serving on the Tuolumne County LAFCO shall not be disqualified from voting on proposals affecting their own special district.

SECTION 3: Special districts shall pay one third of the LAFCO annual budget. Amounts to be paid by each special district for FY 20-21 shall be:

*All cemetery districts and Tuolumne Park & Recreation District to pay at the percentage of district revenue to total special district revenue countywide.

Initial (FY 20-21) allocations shall be adjusted proportionally based on changes to the Tuolumne LAFCO budget annually or as otherwise agreed by a majority vote of the LAFCO Commission.

The LAFCO Commission directs LAFCO staff to bill special districts annually.

SECTION 4. The Commission approves the special district ballot process and accepts the election results.

SECTION 5. The Commission appoints two special district members and one special district alternate to the Tuolumne County LAFCO Commission. Candidates for appointment are those receiving a majority of votes cast by special districts eligible to vote. Appointed members are:

Seat 1 - Rotating Between TUD, Groveland CSD and Twain Harte CSD:

Seat 2 - Special District General Member:
John Feriani, Tuolumne City Sanitary District

It was moved by Commissioner Rodefer and seconded by Commissioner Plummer to appoint Steven Arreguin as the Chairman representative for LAFCO.

PUBLIC COMMENT: 10 Minutes

Commissioner Gray opened the public comment period and asked for those who would like to address the Commission on any item that was not on the agenda.

1. Jacob Barendregt – Notified he is recording this LAFCO Meeting. Mr Barendregt is notifying the commission that he was unable to find the Agenda until 3 days before and claims mineral right ownership.
Mr. Gonzalves notified that it was posted in the Union Democrat on March 16th, posted online on 03/29/2019 at 10:44am, and posted publically in front of the CAO building. Mr. Gonzalves stated that the CRA is working closely with Mr. Barendregt to provide him the information that he requests.
Chairman Gray notified Mr. Barendregt that they will notify him directly of future proceedings if he provides contact address.

Seeing no one else, Chairman Gray closed the public comment period.

PUBLIC HEARING:

1. Consideration of adopting Resolution No. 292 approving the 2018 Municipal Service Review and making determinations for the Strawberry, Columbia, Jamestown, and Mi-Wuk/Sugar Pine Fire Protection Districts.
2. Consideration of adopting Resolution No. 293 approving the 2018 Update of the Spheres of Influence of the Strawberry, Columbia, Jamestown, and Mi-Wuk/Sugar Pine Fire Protection Districts.

Ms. Hendry gave the commission a summary of the 2018 Municipal Service Review for Strawberry, Columbia, Jamestown, and Mi-Wuk/Sugar Pine Fire Protection Districts.

Todd McNeil, Fire Chief TH Fire and Strawberry Fire, requests that the edits they submitted be adopted before approving.

Mr. Gonzalves confirmed that CRA will incorporate their edits to the best of LAFCO Staff's ability.

Steve McClintock, Fire Chief from Mi-Wuk/Sugar Pine Fire, met with Mr. Gonzalves and would like to make sure their changes are accepted as well.

It was moved by Commissioner Rodefer and seconded by Commissioner Plummer to approve Resolution No. 292 and Adopt Resolution No. 293 pending the inclusion of the additions requested by the Strawberry and Mi-Wuk Fire.

3. Consideration of adopting Resolution No. 294 conditionally approving the annexation of the Valley Vista Subdivision consisting of 92.7 acres and additional parcels to the south in Jamestown Sanitary District.

Chairman Arreguin asked if there was anyone else who wished to comment. Seeing no one, he referred the item back to the Commission.

Commissioner Rodefer requests prompt notification to Mr. Barendregt

4. Consideration of adopting Resolution No. 295 approving the expansion of the Sphere of Influence of the Jamestown Sanitary District to include the northwest portion of APN 59-020-68.

Mr. Gonzalves recommends continuing this item to a future meeting, staff will re-notice this item.

Chairman Arreguin asked if there was anyone else who wished to comment. Seeing no one, he referred the item back to the Commission.

5. Consideration of releasing RFQ for augmentation of LAFCO staff.

Mr. Gonzalves gave notification of lower staffing levels and requests permission to submit RFQs for consultants to aid existing staff.

Commissioner Plummer requests care with spend on the budget for overhead.

Chairman Arreguin asked if there was any public comment. Seeing no one, he referred the item to the Commission.

6. Consideration of the Draft Budget for Fiscal Year 2019/2020.

Ms. Hendry gave a summary of the information for the Draft Budget for Fiscal Year 2019/2020 to the Commissioners.

Mr. Gonzalves stated that there are 17 districts. Not 18 as listed in the report.

Comments from Commissioner Gray are in favor of the detail provided. Commissioner Plummer asks if there is an expected steady increase or if this will be a fluctuating budget and will the consultant be kept on an ongoing basis.

Chairman Arreguin asks for Public comment, Mr. Barendregt asks about the billed hours from County employees to LAFCO and if there are duplicate salaries.

Commissioner Plummer asks about the training budget for the Commissioners, Mr. Gonzalves encourages the Commissioners to attend the annual Conferences. Commissioner Gray comments that the public member is the usual attendee.

Commissioner Gray moved for and Commissioner Rodefer seconds

Chairman Arreguin called for the vote: 4, Ayes, 0, Noes; 0, Abstain

Motion Carried 4 – 0 – 0.

7. Consideration of adopting Resolution No. 296 approving the formation of an Independent Special District Representative Selection Committee.

Mr. Gonzalves provided a summary of the *Staff report or recommendation*, offering opportunity for questions and comments on this conditional resolution. He noted staff will change Resolution No. 296 to state 17 districts and remove City of Sonora from the list.

Commissioner Gray asks how many representatives, there will be 17 districts nominating 2 Commissioners & 1 Alternate.

This resolution requires Special District majority agreement on representation and budget prior to next action by commission.

Gray confirms that is all that is being decided on today. Mr. Gonzalves will assemble a special committee to select representatives and then that will be presented to the Commissioners.

Commissioner Plummer asks about committee involvement in recusals and appointments.

Chair opens the floor for public comment, Mr. Barendregt asks if all the districts are being lumped into 1 vote. Mr. Gonzalves comments that special districts can only have 2 seats, these will be appointed by the special district selection committee.

Steve McClintock comments in favor of the special districts involvement and representation in LAFCO. Chairman Arreguin closes Public comment.

Commissioner Rodefer confirmed they are voting to select the Special Districts representatives, and the amendments are made to the 17 districts and the City of Sonora on the Resolution.

Commissioner Rodefer moved for and Commissioner Gray seconds.

Chairman Arreguin called for the vote: 4, Ayes, 0, Noes; 0, Abstain

Motion Carried 4 – 0 – 0.

WHEREAS, pursuant to Government Code Section 56381(b)(1)(A), when there is county, city and special district representation, the default LAFCO budget apportionment is one-third shares for the county, the cities, and the special districts; and

WHEREAS, pursuant to Government Code Section 56381(b)(4), any alternative method of apportionment of the net operating expenses of the Commission may be used if approved by a majority vote of each of the following: the Board of Supervisors; the Sonora City Council; and the independent special districts representing a majority of the combined total population of independent special districts in the County; and

WHEREAS, the special districts seeking LAFCO representation have requested an alternate LAFCO budget allocation formula of 8% to be shared among the special districts.

NOW, THEREFORE, BE IT RESOLVED that the County of Tuolumne Local Agency Formation Commission does hereby determine and order as follows:

SECTION 1: An Independent Special District Selection Committee shall be formed, consisting of the presiding officer of the legislative body of each eligible independent special district. An alternate may be appointed by the legislative body of an independent special district if the presiding officer of that independent special district is unable to attend.

SECTION 3: The Executive Officer is ordered to call and give notice of a meeting of the Independent Special District Selection Committee to be held within 15 days after the adoption of this Resolution. Each eligible district is entitled to one vote on the Independent Special District Selection Committee. Members representing a majority of the eligible districts constitute a quorum. The Executive Officer shall use the operating procedures set forth in Government Code section 56332.

SECTION 4. The Independent Special District Selection Committee shall determine the following by a majority vote:

- a. Do the independent special districts accept representation on LAFCO?
 - i. If so, appoint two regular members and one alternate member
 - ii. Are the special district members to be disqualified from voting on proposals affecting their own special district?
- b. Do the independent special districts accept the default LAFCO budget apportionment of one-third share?
 - i. If not, has an alternate funding allocation been approved by a majority vote of each of the following: the Board of Supervisors; the Sonora City Council; and the independent special districts representing a majority of the combined total population of independent special districts in the County?



EXECUTIVE OFFICER'S REPORT

PROPOSED ACTION

Consideration of adopting the Draft Budget for the Local Agency Formation Commission (LAFCO) for Fiscal Year (FY) 2020-2021, directing staff to send it to the County of Tuolumne, City of Sonora, and Special Districts for review and comment, and approving the LAFCO Fiscal Year 2020-2021 Work Program.

BUDGET

1. Pursuant to Section 56381 of the California Government Code, LAFCO is required to adopt a final budget by June 15th of each year for the next fiscal year which begins on July 1st. The Commission must formulate a draft budget that is to be sent to the City of Sonora, County of Tuolumne, and all the Special Districts in Tuolumne County for review and comment before adoption of the final budget by LAFCO.
2. Staff proposes to keep the LAFCO budget the same as it was for FY 2019-2020; \$65,356. A status quo budget takes into account anticipated financial constraints experienced by member organizations due to the response to the COVID-19 pandemic. Pursuant to Government Code Section 56381, the budget shall, at a minimum, be equal to the budget adopted for the previous fiscal year unless LAFCO finds that reduced staffing or program costs will nevertheless allow LAFCO to fulfill the purposes and programs of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.
3. The proposed budget will provide LAFCO with the funds needed to implement the FY 20-21 LAFCO Work Plan which includes completing Municipal Service Reviews and other LAFCO projects. Proposed budget expenditures are as follows:

4. LAFCO is an independent agency that has historically been funded by the County of Tuolumne and the City of Sonora. In FY 20-21 it will also be funded by special districts as per their request to pay a share of costs and add two special district members and an alternate to the LAFCO Board. Pursuant to a Memorandum of Understanding (MOU) between the City and the County, the Local Transportation Fund (LTF) per capita percentage is used to determine the City's and the County's respective shares of the LAFCO budget. Under this formula, the City will be responsible for 8.1 percent of the adopted FY 2020-2021 LAFCO Budget. In the past, the County was responsible for the remaining balance. With the addition of Special District representatives on the LAFCO Commission, the Special Districts will be responsible for paying one third of the LAFCO operating budget. The County Auditor will invoice the City of Sonora, County of Tuolumne and the Special Districts to pay their respective shares of the proposed costs as shown in the tables below.

EXPENSES

5. **Dues** - The California Association of Local Agency Formation Commissions (CALAFCO) has advised LAFCO staff that the annual membership fee for the upcoming year will increase from \$1,075 to \$1,745 which is a 62% increase. Tuolumne County LAFCO staff gain access to a wealth of information and advice by participating in CALAFCO. CALAFCO provides access to a network of other Executive Officers and LAFCO staff statewide, which provide daily insight and advice on LAFCO procedures and regulations. Without access to this network, Tuolumne

County LAFCO staff would be required to attend more trainings and/or hire additional consultants for assistance.

6. **Travel and Training** - Pursuant to Section 56334 of the Government Code, Commission members and alternates may be reimbursed for actual and reasonable expenses necessary to attend meetings and perform duties of their office. LAFCO may authorize payment of a per diem to Commission members and alternates for each day they attend meetings of the Commission. Based upon LAFCO's past practice, funds are not proposed to be budgeted for City and County LAFCO members to attend LAFCO meetings and conferences or to pay a per diem to any Commissioner. The draft FY 2020-2021 travel budget includes the estimated cost for travel and training for five individuals to attend either a staff workshop or the annual CALAFCO conference. As per past practices, attendees may include LAFCO staff or the regular and alternate Commissioner representing the general public. With the addition of Special District members, the LAFCO Board may wish to consider paying for Special District members to attend the CALAFCO conference if funds allow or directing special districts to pay for their members to attend these conferences.
7. **Personnel** - Staff and consultant costs will remain the same as last year. Personnel costs are based on the County's adopted methodology for establishing hourly rates for each employee. These costs include employee salaries and benefits, and the County's overhead, such as office space, utilities, and internal services, including the Auditor's expenses in handling LAFCO's finances. The number of hours and hourly rates have been estimated for FY 2020-2021.

MUNICIPAL SERVICE REVIEWS

8. Tuolumne County contains 18 independent Special Districts, 7 Lighting Districts and 58 County Service Areas (CSAs). The number of County Service Areas could be increased by developers requesting to add a County Service Area to maintain roads and other services for their development. The Lighting Districts and County Service Areas are maintained by County Staff. Each Special District, Lighting District and County Service Area is scheduled to have their District and Sphere of Influence evaluated every five years pursuant to Section 56425(g) of the Government Code. There are approximately 83 Municipal Service Reviews to be completed. This number could increase if new CSAs are created.
9. From April of 2012 through December of 2013, LAFCO conducted Municipal Service Reviews and Sphere of Influence updates for all the special districts in Tuolumne County. Beginning in

FY 17-18 completion of these reviews were staggered over a five-year period to better manage staff workload. The schedule for Municipal Service Reviews is as follows:

PROJECTS

10. Special districts in the community of Tuolumne have approached LAFCO regarding formation of a Community Services District that would merge some of the special districts in that area into one CSD. This past year, they held a series of meetings with LAFCO staff to discuss the process and plan to hire a consultant to complete a study evaluating the proposed merger. LAFCO staff anticipate reviewing the report in FY 20-21. If an application is made to LAFCO for this project, the costs for the formation of a CSD outlined in the LAFCO fee schedule as "Full cost recovery based on time and materials with a \$3,824.00 deposit".
11. There are two potential projects in Groveland where the developer may apply for boundary adjustments so that the project can be served by the Groveland Community Services District. Groveland CSD may also pursue a proposal to dissolve the Groveland Lighting District and merge its functions with the CSA. LAFCO staff anticipate reviewing these proposals in FY 20-

21. Applications from developers will be accompanied by the appropriate fees as identified in the LAFCO fee schedule.

12. Additional projects may also be submitted to LAFCO during FY 2020-202 that would be added to the FY 20-21 Work Plan.
