4. APPROVAL OF MINUTES:

In consideration of approving the minutes of the meeting held on February 5, Jim Maddox made a motion to approve the minutes. The motion was seconded by Pete Kampa. The minutes were approved unanimously.

- a. CAL FIRE: Unit Forester, Gary Whitson made note of Governor Newsom's recent Proclamation Suspending CEQA for wildfire reduction projects. Whitson noted related concerns and need for clarification, such as: what if the proclamation is rescinded mid-project? Who does the standard apply to? How will environmental management practice accountability be maintained and enforced?
- Stanislaus National Forest Supervisor Jason Kuiken summarized actions within the Stanislaus National Forest. Kuiken also shared staffing adaptations within the region to accommodate Federal funding cuts to the USFS budgets
