  - a. Public comment proposed draft hazardous vegetation management ordinance.
    - i. Section 8.14.060 Duty to remove. Supports general. But does not support the 30' space across the owner's fence line and will be a difficult burden to put on people, especially those with limited income. Solution do not require neighboring landowners to be required to pay, get some funding for folks who will not be able to afford compliance.

- a. TuCare presentation on Community Wildfire Protection Fund (CWPF)
  - i. Representatives from TuCARE are here to talk about their Community Wildfire Protection Fund or CWPF. They introduced organization and then showed a video that they have created to garner support for the CWPF. This presentation is available to anyone.

      - a. Thank you for the presentation, consider adding some current facts of acres burned and CA facts. Not just importance of fuels work but having the personnel and equipment to carry out the evacuations. Increase in funding is needed for fire and law enforcement
      - b. Personal touch of the Washington Fire adds to presentation and important to support the work this committee is trying to accomplish by creating the Fire Safety Advisory Committee. Thank you for your efforts.
      - c. Committee members stated appreciation of efforts and this committee is very passionate about fire safety.

- i. Communication and Education Outreach workgroup
  - a. June 4<sup>th</sup> Tuolumne County Wildfire Preparedness Town Hall. Motherlode Fairgrounds @ 10:00 am. Multiple agencies and partners to have booths and present to the public. Distributed 4,000 packets to families through the Superintendent of schools. Staff will continue to coordinate education and outreach with organizations and others.
- ii. Governance Workgroup updated
  - a. Draft Hazardous Vegetation Management Ordinance out for public review. Three public meetings scheduled May 25<sup>th</sup>, June 1<sup>st</sup> Virtually and then June 15<sup>th</sup>. Comments should be directed to oes@co.tuolumne.ca.us
- iii. Emergency Planning workgroup
  - a. Everbridge test on 5/24. Sirens have been added to emergency alert notification system. OES will be finalizing an Alert & Warning Plan and working with Sheriff and County counsel to develop MOU's for those existing sirens, no new sirens will be allowed until we finalize an application process and approval made on an application.

iv. Everbridge alerts worked and it was great and asked about FM alert and that batteries are an issue and we need to consider that. Staff explained we are continuing to pursue other methods like FM Alert for our emergency alert notification system.

- a. Board of Forestry and Fire Protection (BOF) released its revised Fire Safe Regulations proposal for a 15-day public comment period. Discussion and approval of comments to be submitted. Dave Ruby, Planning Manager for Community Development Department spoke of history and background on fire safe regulations and potential impacts to Tuolumne County. Most recent draft walked back some of the original proposed regulations and letter identifies those areas of concerns.
