V. PARTNER AGENCY UPDATES/PRESENTATIONS

PGE Wildfire Mitigation Plan – Nathan Alonzo gave a presentation on PGE Wildfire Safety. Reducing Wildfire risk in community is a priority. **USFS** – gave update on personnel capacity on Fire staffing in Stanislaus Forest. 50%

CAL FIRE -updated resources, as of June 2 last of the seasonal hand crews are on. As of June 16th, will be fully staffed. We also have a third dozer in the unit (have not had since the 1990's).

Presentation on Fire Risk Reduction Communities List – presentation and discussion of the process, pros and cons. Staff will speak to county counsel on opinion of whether accepting Cal Fire Severity zones could impact down the road. Mandate #1 on ordinance and timing. Mandate #2, Does this hold us to the severity zones. Mandate #3, safety element may have to come back. Mandate #4 on a progress report to obtain list of parcel maps, subdivision correct findings. Staff will bring presentation pf subdivisions with only one way in and out and status of recommendations.

VI. COMMITTEE BUSINESS

- a. Staff Reports and Recommendations
 - OES presented on Emergency Alerts and outdoor audible alert tests May 13th. Lots of calls into our public information line thanking us. Several folks who wanted to be removed from the list. One caller in PML who didn't like the siren and wanted it turned off. OES staff are doing several presentations on wildfire season readiness, upcoming presence at local HOA and or Firewise community meetings.
 - Update on Pinecrest Fire Lane parking (map attached).
 - Shelter Planning updated on our three preferred locations, Sonora Senior Center, Tuolumne, and Groveland CRC. Redcross is our partner, but we will likely have to assist with the initial setup. Training set for end of June for our county staff and volunteers.
 - Home Hardening Project Manager selected, county counsel going through contract and will go to the board on consent June 17th.
 Once on board, we will have a public meeting to introduce and start taking homeowner applications.
 - Community Wildfire Defense Grant is up and not to be confused with the Tuolumne Fire Safe Council grant. Reminded members our grant focuses on three communities. Mi-Wuk Village, Cedar Ridge, and the Yankee Hill side of Columbia. Everyone else outside of those can be served by the Tuolumne fire Safe Council grant. It will also cover about 22 miles of county maintained roadside brushing that will be cleared by Sheriff's Jail Crew.
