V. PARTNER AGENCY UPDATES/PRESENTATIONS

Tuolumne Fire Safe Council update Karen Caldwell announced TFSC president Mike Olincek resigned, Karen interim. 21 Firewise communities now, 3 in progress. TFSC status update: Mountain Boy project complete, contractor paid. Apple Valley complete. Smith Station this fall (CEQA finished), Big Hill maintenance underway. Kewin Mill and Dragoon Gulch starting CEQA, also connected to Jamestown project. Starting 8 defensible space projects in Groveland. Likely moving to Columbia next – multi-year. Council will be submitting for CalFire grants, nothing coming from Federal funding.

CAL FIRE – controlled burns wrapping up. Summary of aviation assets and capabilities. Invitation to meet at Columbia attack base. OV-10 control craft (2500 AOG), 2x S2T tankers, and Blackhawk.

SWIFT - Lindsay Mattos provided update on two NOFO Wildfire defensible grants (BLM & CalFire)

a. Subdivision review for Risk Reduction Communities List and approval of working towards recommendations to improve each identified subdivision's fire safety. – Staff presented the program and definition: 30+ home areas with no secondary egress. We know we have more neighborhoods/areas in challenging conditions than those that are on the current list. Explanation of criteria and recommendations for becoming a "fire risk reduction community" with prioritized actions. Committee discussed road clearance jurisdiction issue – handling red flag warning conditions (awareness and citation), suggestion to model LA/Orange county best practices, Emphasize education/outreach vs. enforcement and summary listing of each recommendation and status.

What commitment (if any) are we as a committee making, and to what extent (i.e. nominated subdivisions only? County wide? Etc.) Staff asking to move forward with prioritization and assessment. Sonora Hills example – impact of drills on building awareness & readiness especially among the more elderly/at-risk cohorts with respect to mobility, enrolling mass-movers like YARTS, TCTC, School District...
