# V. PARTNER AGENCY UPDATES/PRESENTATIONS

**Tuolumne Fire Safe Council** update – Karen Caldwell: grant apps in progress – CalFire prevention, Tuolumne City & Big Hill, TUD for ditch area. Mid-August start on Groveland project. Defensible space contractor training this week.

CAL FIRE – August 5<sup>th</sup> Chicken Ranch Agreement on BOS Agenda

**SWIFT** - Spoke about 360 tool for veg treatments and 8/24 demo.

### VI. COMMITTEE BUSINESS

**Staff Reports**: Sheltering status (3 sites) and Red Cross relationship. Noting parking, generators availability. Cache of cots/tarps/comfort kits. Increase in ARC volunteer staff, esp. on 120 corridor. Reminder, all TC employees are DSWs. 2hr window for OES+volunteers opening shelter then ARC staff take over. MotherLode fairgrounds: secondary only (due

to expense and it's actually state property). Committee asked about FMAG status for MLF option, provision for infrastructure. Non-service animals may not enter CRCs. Sheltering rules require accommodation for co-location of pets at (at least) one shelter. Coordinating through Animal Control – options include schools, portable connex. ARC does NOT handle animal care, it will be County responsibility to shelter, but Clients are responsible for feeding, meds, exercise. No Mutual Aid agreements currently for overflow with respect to animals.

- b. ADDED ITEM: Approval of recommendation to BOS to support Cal Fire Wildfire Prevention Grant. Sheriff explained grant application to utilize jail crew for roadside brushing to focus on Cedar Ridge, Big Hill Rd areas and Cedar Pines Vista (Twain Harte). August 5<sup>th</sup> deadline. Roadside brush clearing is primary work category. Requested committee recommendation to the BOS to support application. Motion to approve letter: Supervisor Griefer, 2<sup>nd</sup> Scott Fremd, motion passed without abstentions.
