The Tuolumne County Community Development Department requests your assistance in reviewing this land development project proposed near your property. We value your comments and participation in our planning process.

We are in receipt of an application from Thomas Stansberry for Conditional Use Permit CUP20-014 to allow the development of a new 80 foot tall wireless communications tower and related equipment within a 10 by 10 foot fenced area. The project site is a 1.0 ± acre parcel zoned RE-2 and MX (Residential Estate, Two Acre Minimum and Mobilehome Exclusion Combining District) under Title 17 of the Tuolumne County Ordinance Code.

Location: The project site is located at 5999 Arbolada Drive in the Community of La Grange, approximately 718 feet North of the intersection of Enramada Drive and Arbolada Drive. 







