Update to Tuolumne County Buildings COVID Safety Requirements

In response to the changing regulations from the State of California, Cal/OSHA, and California Department of Public Health (CDPH), Tuolumne County is updating its COVID safety policy in government buildings.

Effective June 23, 2021 the County of Tuolumne made modifications to the six ft. physical distancing and facial covering requirements within County buildings.

Upon entering a County building, signage has been posted stating, "Attention! By entering this location without a face covering you are self-attesting that you are fully vaccinated". This modification excludes, public transit, school and childcare settings, healthcare settings, state and local correctional facilities and detention centers, homeless shelters, emergency shelters, cooling centers, and other similar settings where double-layered face coverings are required for all, regardless of vaccination status. Please see CDPH's June 24, 2021 Guidance for the Use of Face Coverings.

The Board of Supervisor Meetings will reconvene July 6th and fully open to the public. Six-foot physical distancing is no longer in effect and facial coverings are not required for those who have been vaccinated.

Members of the public can continue to provide public comment if they do not wish to be physically present by calling 209.533.6581 to queue for verbal public comment. Public Comment will be opened and closed individually for each agenda item when the Board Clerk reads the item and will be limited to three minutes.

The Board Chair will ask members of the public who are physically present to make comments first and then he will ask members of public in the phone queue to comment.
