What is a Full Service Partnership? (FSP)

The FSP Children's Program is designed for children ages 0 through 15 and their families who are interested in participating in a program designed to address the total needs of a family whose child is experiencing significant emotional, psychological, or behavioral problems that are interfering with their well-being and the well-being of the family members and the community.

A child with a Serious Emotional Disturbance (SED) and may not have responded well to traditional outpatient mental health and/or psychiatric rehabilitation services or those individuals who have incurred high costs related to o acute psychiatric hospitalization or long-term care.

Who is eligible for Children's FSP services?

Children ages 0-15 years old (eligible for mental health services) with a Serious Emotional Disturbance (SED) who meet the following criteria in the last 6 months:

- Seriously Emotionally Disturbed
- > At risk of being removed from the home
- ➤ Has extreme behavior problems in school/home
- ➤ Has been in an out-of-home placement and is moving back into a home/community setting
- Unserved or underserved



What services are provided for participants in FSP?

FSP provides comprehensive, intensive mental health services for individuals in their homes and communities. For individuals in need of these services, the following are examples of services that you might receive if you were participating in an FSP Program: Individual and family counseling and psychotherapy

- Field-based and in-home case management services
- Peer and family support services
- ➤ 24/7 Crisis assessment services
- > Social / recreational skills training
- Pre-vocational services
- Assistance accessing community resources
- ➤ Help with accessing educational opportunities
- Has been involved with probation and transitioning to a less structured home/community setting
- Assistance getting the financial and health benefits your child and family is eligible for
- Referral and linkage for treatment of harmful addictions such as drug and alcohol use and misuse of prescription medications.

Assistance with housing services to help with finding suitable housing for your child and family.

Wrap Around Services

Wrap around services use a team approach to meet you and your family's needs. It gathers your family, community-based services, and natural support people already in your life together to come up with a plan to try to meet your child's needs and the needs of the family.



How are people referred to FSP services?

To be considered for a Children's FSP program, a referral must be submitted and screened for eligibility. Anyone in the community can refer a person to FSP.

If your child is accepted into FSP program, you will be contacted by one of our assigned FSP service provider/s who are dedicated professionals committed to accomplishing goals that are important for you or your family's success.
