Re: Public Contract Code § 22031(b)(2); New Road Construction or Reconstruction by Force Account – Kewin Mill Road Paving from Broken Pine Road to Estralita Drive from September to October 2023.

Whereas, Public Contract Code (PCC) section 22031(b)(2) authorizes the County Road Commissioner to utilize the procedures set forth in Article 25 (commencing with Section 20390) of Chapter 1 of the PCC, as an alternative to the procedures set forth in the Uniform Public Construction Cost Accounting Act, to perform new road construction or road reconstruction; and

Whereas, Section 20395(a)(3) allows the Board of Supervisors to authorize the County Road Commissioner to perform work upon county highways under the supervision or direction of the County Road Commissioner by purchasing the material and having the work done by day labor, in which case advertising for bids is not required; and

Whereas, Tuolumne County by Resolution 90-23 authorized the Tuolumne County Road Commissioner to have any work upon county highways done under their supervision and direction, pursuant to Section 20395; and

Whereas, Section 22031(g) that requires any county acting pursuant to PCC section 22031(b)(2) declare its intentions to use this provision prior to commencing work; and

Whereas, Tuolumne County by Resolution 35-23 appointed Kim MacFarlane, Director of Public Works to serve as the Tuolumne County Road Commissioner under the direction and supervision of the Board of Supervisors in accordance with Section 2005 of the California Streets and Highways Code, effective April 18, 2023:

I hereby declare as the Director of Public Works and Road Commissioner, that as an alternative to the procedures set forth in the Uniform Public Construction Cost Accounting Act, I intend to utilize the procedures set forth in Article 25 (commencing with Section 20390) of Chapter 1 of the PCC in connection with the following work: Kewin Mill Road Paving (cost center 1101-301200-542592) from Broken Pine Road to Estralita Drive.
