### About the CWMP

The California Wildfire Mitigation Program (CWMP) was created as part of the State of California's effort to strengthen community-wide resilience against wildfires. The California Governor's Office of Emergency Services (Cal OES) has partnered with the California Department of Forestry and Fire Protection (CAL FIRE) to develop a state home hardening initiative to retrofit, harden, and create defensible space for homes at high risk to wildfires.








### Defensible Space

#### Example mitigations:

- Miscellaneous combustible removal
- Vegetation modifications
- Tree Limbing/Removal
- Woodpile relocation
- Log/Stump removal
- Spacing of trees/shrubs
- Addressing

Exterior Siding Retrofit



Exterior covering will be color matched to existing siding

Replacing warped exterior wall assembly to prevent ember intrusion

Work is completed by licensed and bonded contractors



Exterior covering will be replaced with fireresistant cement board to resist radiant heat and flames



Tuolumne County OES








### Who is Eligible to Apply

The home must be in the highlighted property area

Only the legal owner of the property may apply

Must be willing to sign a right of entry document

 Allows home assessors and contractors onto the property to assess risks and conduct work









### Who Is Eligible to Apply

Any homeowner in the project area may apply, regardless of income.

Per HCD, as of April 23, 2025

- At this time, homeowners with a household income over 120% of the Tuolumne County Area Median Income (AMI), considering household size, will pay a cost share of 10% of the total project cost.
  - **Example** Household of 4 people, with a household income of \$121901.00 would pay \$4,000 on a project if their total site work cost \$40,000
- Homeowners with a household income over 200% AMI, considering household size, will pay a cost share of 25%
  - **Example** Household of 3 people, with a household income of \$182,901 would pay \$10,000 on a project if their total site work cost \$40,000







### How Can We Prepare?

- Maintain your defensible space
  - Remove combustible materials from gutters and roofs
  - Remove flammable items from underneath decks and porches
  - Relocate combustible materials from within the first five feet of the home

### Project Lifecycle

- Homeowner applies
- Project staff reviews applications
- Project staff contacts eligible homeowners to schedule free home assessment
- Assessment report is reviewed, and scope of work is created based on recommendations
- Scope of work is reviewed with homeowner
- EHP review is started
- EHP Reports sent to FEMA in batches







### Project Lifecycle Continued......

- FEMA approves and awards the batch
- Project staff acquires contractor bids for the scope of work
- Project staff awards most competitive and responsive bid(s)
- Project staff, contractors and homeowners complete triparty agreement, cost-share payment (if applicable)
- Site work begins
- Site work is completed
- Project staff completes final walkthrough and closeout activities
