**NOTICE IS HEREBY GIVEN** by the Clerk of the County of Tuolumne, State of California, that in accordance with the provisions of the election laws of the State of California, there will be a Statewide Special Election on Tuesday, November 4, 2025.

**NOTICE IS FURTHER GIVEN** that the last day to register to vote for the November 4, 2025, Special Election is October 20, 2025. Conditional Voter Registration is available beginning October 21, 2025, and through Election Day for those who miss the registration deadline and want to register to vote and receive a ballot the same day.

**NOTICE IS FURTHER GIVEN** that the Elections Office will have vote-by-mail ballots in the mail to all eligible county voters by October 6, 2025, and that the last day for eligible voters to request a vote-by-mail ballot by mail is October 28, 2025.

**NOTICE IS FURTHER GIVEN** that Tuolumne County has adopted the Voter's Choice Act election model. As part of this adoption, **voters no longer have an assigned polling place** and can go to any vote center located in Tuolumne County during the in-person voting period. A select number of vote centers will open 10 days before Election Day, with the remaining vote centers opening three days prior. During the in-person voting period, open vote centers will be available to voters 8:30 a.m. to 4:30 p.m. each day, except for Election Day, when all vote centers will be open from 7 a.m. to 8 p.m.

**NOTICE IS FURTHER GIVEN** that after the closing of the polls, ballots will be transported to the central counting location on the first floor of the Tuolumne County Administration building at 2 South Green Street, Sonora, CA 95370.

**NOTICE IS FURTHER GIVEN** that per California Elections Code §15104, the County Clerk of Tuolumne hereby notifies all interested parties that the verifying of signatures on vote-by-mail ballots and the opening and processing of vote-by-mail ballots cast for the November 4, 2025, Special Election will commence on October 6, 2025, or at any time thereafter at the Tuolumne County Elections Office located on the second floor of the Tuolumne County Administration building at 2 South Green Street, Sonora, CA 95370. This process will continue until all election results are tabulated and the election is certified.
