SUBJECT: Presentation on the status of the State of California's 2016 Community Development Block Grant National Disaster Resiliency Competition Project

In October 2015, the State of California submitted the Community and Watershed Resilience Program for consideration for the 2016 Community Development Block Grant National Disaster Resiliency Competition (NDRC). On June 2, 2016, an official notice was published in the Federal Register regarding NDRC grant awards and requirements. Out of 56 applications, the State of California was one of 13 who received NDRC grant awards.

The State of California had applied for \$117,000,000 and was awarded \$70,340,770 in grant funds. The NDRC grant application included funding for the following project categories:

- **Forest and Watershed Health** - Lead Agency: Sierra Nevada Conservancy
Requested: \$40,000,000 Received: \$28,604,459
- **Community Resilience Centers** - Lead Agency: Tuolumne County
Requested: \$55,000,000 Received: \$19,736,311
- **Biomass Facility/Wood Projects Campus** - Lead Agency: Sierra Nevada Conservancy
Requested: \$22,000,000 Received: \$22,000,000

Since the announcement of the NDRC Grant award, the Core Team (Governor's Office of Planning and Research, Housing and Community Development, California Environmental Protection Agency, California Fire, Sierra Nevada Conservancy, United States Forest Services, and Tuolumne County) has been working hard to: a) put together the organizational structure for this project; b) submit all of the required paperwork and action plan to Housing and Urban Development (HUD); and c) finalize the agreement between the State and HUD.

With Agreements and Memorandums Of Understanding in the process of being signed by the various Core Team Member Agencies, we are ready and excited to officially kick off the third phase on the NDRC Project. The Core Team Members will be attending your Board meeting to
