SUBSTANCE USE DISORDER PROGRAMS

- ***Substance Use Disorder Treatment:*** Individual and group treatment for persons with a substance use or addiction problem.
- ***Dual Diagnosis Treatment:*** Counseling for clients who have substance use problems, in addition to a mental health disorder.
- ***Perinatal Treatment Program:*** Specialized substance use disorder treatment for pregnant and/or parenting women.
- ***Adolescent Substance Use Disorder Program:*** Intervention for teens using alcohol and/or drugs through individual, group and family counseling, as well as prevention and brief intervention services for referrals from schools, the Juvenile Detention Facility (JDF) and the Probation Department.
